Looking for House Parents (Foster Parents)!

Nana's House is a privately run Christian Children's Home in Brevard County providing for neglected, abused, needy or abandoned children. We are 100% volunteer (no paid employees) and 100% community funded (no state or federal funding). We are accredited throught the Florida Association of Christian Child Caring Agencies (FACCCA) who inspects and audits our homes annually.

We help children ages 0-11, whose parents/grandparents, for various reasons (drugs, incarceration, aging grandparents), are no longer able to care for them. We keep siblings together and provide a safe home until the natural home is stabilized or until permanent care can be arranged. We provide love, food, shelter, clothing, homeschooling education, transportation, recreational activities and educational outings. By providing these services, we expose the children in our care to all aspects of a loving, family environment. Each home has a set of house parents, mother and father. The mother stays home to care for the children and the father is employed outside the home. House parents are not paid and the income the father receives is theirs to keep and save. ALL living expenses are paid by Nana's House including a minivan.

And this is where **we need your help** to spread the word to your congregation that we are in need of house parents (foster parents). Very shortly, we will be opening an emergency shelter for children who need less than 3 months of emergency care. This has been an overwhelming need in the community, which we have not been able to meet due to the rapid rotating door lifestyle this would subject our long term residents to. Accordingly, we are now poised to not only create a home specifically designed to fill this emergency need, we are also set to train a very special couple for this 'amazing' new challenge.

We're also seeking house parents (foster parents) for our Gated Community where we will have 8 homes with 5 children each, a community building, pool, playground and everything it takes to make a beautiful, safe environment for these less fortunate children.

We've broken ground and six local builders have stepped up to build the eight 2,400 sf houses on the property. Three families have donated \$100,000 each to build the homes. Other local contractors, building suppliers, and businesses have also stepped up to donate supplies, furnishings, and their skills to make this dream a reality. We are still actively seeking more house sponsors.
